SCHEME OF ENTRUSTING CREDIT AUDIT WORK TO RETIRED EXECUTIVES/OFFICIALS OF OUR BANK.

ELEGIBILITY CRITERIA:

▶ Retired Executives of our bank (Scale IV and above) with Credit Exposure of minimum period of 3 years.

AND/OR

Retired Executives who had worked as Branch Head in our Bank while they were in scale **III** and above for a minimum period of 3 years

AND/OR

Retired Executives who have worked in our Zonal Inspection Centre/CIAD for a minimum period of 3 years.

Provision:-

- ▶ Retired executives will be eligible for such work only during first 5 years from the date of retirement / superannuation and up to age of 65 years.
- ▶ Services of Retired Officers in Middle Management Grade III with similar Qualification / experience may be utilized at the places where Retired Executives are not available (Power to be vested with GM, CIAD).

Disqualification:-

▶ Retired personnel against whom punishment/penalty was imposed by the bank with a punishment of compulsory retirement, removal from service & dismissal.

Role Expectations:-

The selected Credit Auditors will be required to carry out the credit audit of the allotted account/s within the purview of Bank's extant guidelines as amended from time to time.

SELECTION PROCESS:

- (1) Applications received from retired executives after verification by RO/ZONE/ZIC/CIAD to be recommended to General Manager, CIAD for final approval.
- (2) Selected candidates will be assigned credit audit of accounts at their local stations as far as possible.
- (3) Each Credit Auditor would be assigned credit audit of maximum 3 accounts per quarter (i.e. 12 accounts per annum). Assignment beyond permissible limit world be subject to prior permission of General Manager (CIAD).
- (4) Performance of Credit Auditors is to be reviewed on annual basis.
- (5) Selected Auditors may be given required training for credit audit work.

OTHER TERMS & CONDITIONS:

- ▶ Selected executives have to accept the terms & conditions for conducting credit audit and execute undertakings as required by the Bank in consultation with Bank's Legal Deptt.
- ▶ Selected executives will not be allowed to conduct credit audit of accounts processed/recommended /sanctioned by them in the past.
