- 3. Discussion and adoption of General Secretary's Report and Accounts
- 4. Organisational Matters
- 5. Legal Matters and issues
- 6. Suggestions from Zonal Secretaries, if any
- 7. Any other matter with the permission of the Chair

All Zonal Presidents, Zonal Secretaries, National Vice Presidents and Asst. General Secretaries, members of the Central Legal Group were invited as ex-officio members to participate in the meeting. In all -49- members as stated above participated in the meeting. Shri K.L. Bansal, National President presided over the meeting.

At the inaugural session on the meeting, Shri SNS Yadav, Zonal Secretary, BOBROA, Lucknow Zone, welcomed the dignitaries on the dais, invited Guests viz. Shri H.S. Prasad, DRM, Varanasi Region I, Shri R. K. Singh, DRM, Varanasi Region II, Shri Sanjay Kumar, Chief Manager, Ind. Est. Branch, Shri Rakesh, Chief Manager, Lanka Branch, Shri Gaurav Chaturvedi, President, AIBOBOA, Lucknow Zone and invited Principal Office Bearers of Zones, Governing Council members and members of CLC of BOBROA.

The meeting commenced by invoking the blessings of the Almighty by the dignitaries on the dais which was followed by Lighting of the Lamp and garlanding of the photograph of Late Maharaja Sayajirao Gaekwad III, founder of Bank of Baroda. This was followed by extending floral welcome to the invited Guests.

Shri K. A. Jafri, Zonal President, BOBROA, Lucknow Zone, delivered the welcome address and shared that Varanasi is also called to be Moksh Nagri and also known as the spiritual capital of India and City of Temples. He expressed that the -02- day Core Committee meeting would be fruitful by the meaningful participation of one and all.

Thereafter, Shri J.G. Lakhawala, General Secretary, BOBROA, briefed on the activities of BOBROA and the rationale behind its inception in 1990 by the likeminded Officers Shri V.T. Makwana and Late Shri A.A. Raval along with a few other retiree officers. He also shared that BOBROA was established as a platform to meet and greet each other and represent the problems of the retirees to the management. BOBROA was nurtured further by Shri K.L. Bansal, National President and Shri J.G. Patel, Executive President and at present, BOBROA has 14000+ members with 49 overseas members. At present, BOBROA has -12- Zones as per the setup of BOB prior to merger of e-Dena and e-Vijaya. Shri Lakhawala also shared that at the instance of BOBROA, the then Chairman Late Shri P.S. Shenoy, extended the benefit of the Contributory Medical Scheme barring a few cases. Gold Coins were also given to the retirees on the Centenary Year celebrations of the Bank. Other benefits enjoyed by the retirees were also briefed to the august gathering. It was also shared that with the persuasion of BOBROA, the ExGratia benefit given to the Pre 1986 retirees who were given very meagre amount has also been increased by an additional amount of Rs. 8000/-. Further, it was informed that elections are being held

regularly in a democratic manner. BOBROA has been given very good support by the management as also from the in-service Organisation i.e. AIBOBOA officials viz. Shri Prem Makker and Shri R.K. Chatterjee and their Zonal Units.

Recollecting the deliberations during the 7th Quadrennial Conference held at Ahmedabad during May, '2022, Shri Lakhawala informed that as per the suggestion of ED Shri Joydeep Dutta Roy, BOBROA along with other Retiree Organisations have come together and requested Bank for a meeting, the date of which is still awaited. A -19- point Agenda has also been sent to the Bank.

Praising the performance of the Zones, Shri Lakhawala also informed that certain Zones are also discharging CSR responsibilities towards the society. This initiative enhances the prestige of BOBROA. Thereafter, the members present at the -2- day Core Committee meeting were thanked by the General Secretary, Shri Lakhawala. He also acknowledged the presence of the Management Representatives and the Office Bearers of AIBOBOA.

While addressing the house, Shri H.S. Prasad, DRM, Varanasi Region – I, began the address by chanting "Har Har Mahadev" and applauded Zonal Secretary, Shri SNS Yadav. He also acknowledged the presence of all yester year Executives with whom he had worked and the fruits which they presently enjoying are due to the hard work put in by them for which they were thanked.

President of AIBOBOA, Shri Gaurav Chaturvedi, while addressing welcomed all to the pious city of Varanasi. Formation of BOBROA itself proved its success as it has grown from 5-7 members to 14000+ members at present. He shared that the working style of BOBROA, Lucknow Zone has inspired him. He also acknowledged the efforts put in by BOBROA as a result of which the benefits have been extended by the Bank to the Retirees like subsidy on Medical Insurance etc. He concluded his address by recommending the delegates to visit the holy places of Varanasi.

Shri K. L. Bansal, National President, BOBROA, began his opening address by welcoming one and all on behalf of Central Team. Recollecting the memories of the time spent during his childhood in Varanasi and on repatriating from Fiji as Zonal Head, UP Zone etc. shared that today BOBROA has grown strong as it has 14000+ members. He also informed that the rationale behind hosting the Core Committee meeting at Varanasi was that it being a holy place would help BOBROA in resolving its pending issues with the blessings of Lord Shiva. He also gave his blessings and the mantra of living a happy life by being happy and tension free so that it would serve as a medicine to remain disease free and a healthy life.

Subsequently, National President, Shri K.L. Bansal, General Secretary, Shri J.G. Lakhawala presented mementos to the Bank Executives and President AIBOBOA. This was followed by vote of thanks to the invited guests by Shri SNS Yadav, Zonal Secretary, Lucknow Zone and thanked them for the return gift given to the delegates.

After the inaugural function, National President, Shri K.L. Bansal, initiated the proceedings for the Business Session and inviting Zonal President, Zonal Secretaries, National Vice Presidents and Asst. General Secretaries informed that the purpose is to escalate matters discussed to members.

As regards to the first agenda item, the minutes of the last Core Committee meeting held at Vadodara on 21.11.2021 which was circulated amongst the members, the House to confirmed the same. Two minutes silence was observed to pay homage to the departed souls during the period under reference.

It was shared that the number of retirees y-o-y are drastically going down hence emphasized on canvassing maximum members thereby bringing them into the fold of BOBROA. He also pointed out that to access the strength of the Organisation vests on the number of its members and its financial strength. In order to address the inflation, rising costs and reducing rate of interest on deposits, the need of the hour is to step up the membership drive.

This was followed by highlighting Shri Dr. Jawahar Karnavat, Asst. General Secretary, Bhopal Zone for

his contribution towards enriching Hindi language Globally and Research on Hindi journalism at the "World Hindi Sanmaan" at Fiji. Dr. Karnavat was conferred upon the award at the gracious hands of Shri S. Jaishankar, Minister of External Affairs, Government of India at Fiji. All the members present at the meeting congratulated Dr. Karnavat on his outstanding achievement.

Regarding the 2nd agenda item, General Secretary, Shri Jagdish Lakhawala presented his report highlighting the activities undertaken by BOBROA post the 7th Quadrennial Conference held at Ahmedabad during 27th & 28th May, '2022. The report contained information regarding membership of BOBROA, its financial position, issues taken up with the Bank, Zonal activities, Group Medical Policy, Industry level issues, status of legal matters etc. etc.

The discussion and adoption of the General Secretary's Report and Accounts commenced as Shri K.L. Bansal, National President inquired from the house as to whether any matter of the report of General Secretary needs to be discussed. Shri Thirumalai, Zonal Secretary, Chennai Zone proposed to the house to accept the General Secretary's Report which was seconded by Shri Subhash Ahuja of New Delhi Zone. The General Secretaries Report and the Audited Income & Expenditure Account as on 31.03.2022 were adopted unanimously by the house.

As regards agenda item on the organisational matters, it was proposed to increase the membership fee of Family Pensioner (whose spouse was not the member of BOBROA) from the present Rs. 600/to Rs. 1,000/- with immediate effect. It was also a suggestion from Bareilly Zone.

To this, Shri Thirumalai of Chennai Zone suggested to keep this on hold for the present. However, Shri Ravindran of Pune Zone suggested increasing it form 01.04.2023 instead of immediate effect. Further, he suggested that old retirees who are yet not members to be given opportunity to become members at the rate prevailing at the time of their retirement. To which, Shri Jatil Patel, Executive President rejected the suggestion considering the present financial health of BOBROA as the Income & Expenditure Account for the 09 months period of F.Y. 2022-2023 showing negative trend.

Shri Deshpande of Pune Zone suggested of controlling expenses by conducting meetings virtually. To this, Executive President, Shri Jatil Patel replied that this is a good option. However, attending such meetings personally is essential as it facilitates to understand the working of BOBROA. It was also informed that the next meeting of Governing Council members or General Body would be decided at least -04- months in advance so that less expenditure on travelling / meeting expenses could be incurred.

Suggestions / strategies were invited from the house on how to lower the expenses and increase the income and also how it can be implemented.

The next item taken up for discussion on Organisation matter as a stride towards curtailing of expenditure, it was informed that the printing of Members Handbook has been dispensed with and instead it is placed on the website of BOBROA for ready reference of the members. It was also informed that inducting the retiree officers of e-Dena and e-Vijaya at a discounted rate cannot be entertained. Shri Subhash Ahuja, New Delhi Zone concurred to the concern expressed by Executive President but though increasing the membership fees of Family Pensioners to Rs. 1,000/- is less as our income will not increase substantially but our objective is to help the Family Pensioners as they require it most.

Intervening to this, National President, Shri Bansal, from his experience stated that discussions on this issue has no end. So, instead of discussing more it's better to increase the membership fees of Family Pensioners whose spouse was not our member from Rs. 600/- to Rs. 1,000/- from 01st March, '2023 to which the house agreed.

There was as suggestion from the Central Team that there is generally a slight increase in DA on pension which is experienced twice in a year. Keeping this at the backdrop and if it is agreeable to all, it was proposed that every pensioner to donate at least the amount of increase in DA at least once in a year. This suggestion was refused. Shri Lalit Astana of Bareilly Zone suggested that all office bearers,

ZC and GC members etc. to contribute Rs. 2,000/- every year. But, to decide the modalities, National President, Shri Bansal suggested to form a committee and they should come out with the recommendations on how to increase the income and reduce the expenses.

The members of the committee are:

- 1. Shri S. Thirumalai Chennai Zone Shri Mayur J Shah, Baroda Zone (Convener)
- 2. Shri B S Dhaka, Jaipur Zone
- 3. Shri Sampat Pawar, Pune Zone
- 4. Shri K. K. Batra, New Delhi Zone

It was further informed that the committee would conduct virtual meetings and would submit their report by 31st March, '2023.

Afterwards, National President, Shri Bansal, invited Shri Mayur Shah, Governing Council member, Baroda Zone to present himself and his working on the strategies adopted for driving the membership.

It began with comparing new membership numbers vis-a-vis fees received which revealed that it has reduced y-o-y basis from 986 members and Rs. 40/- lacs in 2017 to -436- members and Rs. 22/- lacs in 2022.

Anticipating the reduction in superannuation in the coming years as also the merged banks having their own active association, Central Office decided to focus on membership drive and thus the list of 16008 non-members was circulated in July, '2022 with all basic data of ex-employees in order to bring them into the fold of BOBROA. The entire non-members list was bifurcated into -06- categories viz. BOB self, BOB family, EXDB self, EXDB family, EXVB self and EXVB family. Each zone was provided with the list of employees retiring in next month with all the above basic data and also provided every month the list of non-members of 2022 retirees, in addition to the previous list reduced from 16008 members. The membership started increasing week by week and reached to appreciable level on 30th September, '2022. Central office decided to surpass membership number of 14000 running members by 31st January, '2023. Each zone responded and target of 14000 was crossed on 31-12-2022 the number stood at 14003 members.

A new initiative was taken recently and Central office formed a WhatsApp group of each Zonal President and Zonal Secretary. Central office has decided to reduce follow up for prior to 2022 retirees having EC number above 1 lac for obvious reasons and reduced file consisting the list of 16008 non-members to 4100 non-members of Bank of Baroda only. Further, -05- files were provided over Whatsapp comprising of March 2023 retirees, February 2023 retirees, non-members of January, '2023 retirees, non-members of '2022 retirees, prior to '2022 retirees, Zone wise summary of each category with pending numbers of non-members. Besides the above list of non-members, VRS optees of last year are to be enrolled as members immediately. The august gathering was informed that the vision of Central office is to surpass the '2018 membership number of 828 and even surpass the running membership number of 15000 in '2023. It was concluded that this vision can be achieved and appealed to all to do it at the earliest.

Executive President, Shri Jatil Patel supplemented and complemented all by saying that results towards membership drive in the first -02- months of CY 2023 is very encouraging as -89- members have been enrolled with Pune Zone topping followed by Bareilly, Jaipur and New Delhi Zone. Many Zones who have not performed well are themselves aware hence the names of the Zones were not highlighted. The remaining Zones have started against the set target of making -830- members. However, Executive President proposed to make the -830- members by Oct. / Nov. '2023 and the members made in the remaining period of 2023 would be a bonus.

Further, he briefed on the age of the members that out of -89- members made in CY 2023, -36-members are from 31.12.2019 till 2022, -34- members enrolled have retired prior to 2018 which is yielding results as it is clearing the backlog of non-members. Till '2022 the average donations was Rs.

4/- lacs which can be surpassed looking to the present trend hence he appealed that the members present should communicate to other members on their going back to their respective Zones by which the Balance Sheet would become better.

National President, Shri Bansal appreciated the CSR activities undertaken by Jaipur, Pune and New Delhi Zones. However, it was suggested that such funds collected should be reported on quarterly basis to the Jt. General Secretary, Shri Harshad Desai who in turn would highlight the activities in the e-Bulletin Magazine "Sampark".

Shri Lakhawala, General Secretary, informed about the resignation received from Shri Prakash Pandya, Asst. Finance Secretary which was tendered on account of his social reasons as such was accepted and in his place Shri Sunil Chaubal has been entrusted with the responsibility to assist the Finance Secretary, Shri Kamlesh Parekh. It was further informed that this would be ratified at an appropriate time.

The next item taken up on the agenda was the suggestions received from various Zones and the General Secretary, Shri Jagdish Lakhawala candidly replied to the suggestions in -03- categories viz.

- 1. Some suggestions which were already implemented
- 2. Some of them are already taken up at the appropriate level
- 3. Some issues will be taken up with the Management and
- 4. Some of the suggestions cannot not be implemented

Suggestions from some of the Zones were received late i.e. on the date of the meeting and hence could not be discussed but they are almost identical to the suggestions discussed.

On 28th Feb. '2023, National President, Shri Bansal initiated the proceedings by reiterating that from 01.03.2023, an amount of Rs. 1,000/- should be donated every year onwards to which the house, in one voice agreed unanimously.

Two members were felicitated viz.

- 1. Shri B S Dhaka, Asst. General Secretary, Jaipur Zone on account of his birthday and
- 2. Shri D.D. Maheshwari, Zonal President, New Delhi Zone on his attaining the age of 75 years

Before taking up the next agenda of Legal matters and issues, the National President, Shri Bansal assured to the house that he would be personally looking in to the pending Legal issues whereby it is brought to a logical conclusion.

The Convener of Legal Cell, Mr. C. Malolan presented to the house a brief of the pending legal issues as under:

- 1. Regarding Pension Updation: BOBROA had filed a petition in Gujarat HC WP 4258/2019. The case is yet to come up for hearing. Since the same issue is already before Supreme Court in M C Singla case, we should not pursue the matter at Gujarat High Court.
- 2. Inclusion of Special Allowance for terminal Benefits: WP 35691/2019 AV Jose & 7 others: (BOBROA has impleaded in the case): The case is pending at the division bench at Kerala High Court. Date for Bank's advocate arguments awaited.
- 3. ARB / Additional Gratuity: SCA 15032/2022 has been filed in Gujarat HC. Bank has submitted its reply: BOBROA will give a rejoinder in consultation with our advocate.
- 4. Contempt petition in 1616-1684 DA merger case before Supreme Court: Similar contempt petition filed in madras high court was dismissed as the contempt court cannot decide on the quantum of payment. Since the petition to be filed in Supreme Court was on similar lines, it was

suggested by the legal team to drop the contempt petition route and explore the possibility of raising the issue of payment amount before the Supreme Court. The house authorised the same.

- 5. A M Sampat Case: The case of BOB V/s A M Sampat & Ors.: The case had been dismissed by the Supreme Court on the lines of IOB CASE decided recently where it had been held that different cut-off dates in a settlement is acceptable.
 - Mr. Thirumalai, Zonal Secretary, Chennai Zone, who had been following up the case in Madras High Court made a strong appeal to go for a revision petition.
 - Mr. Vachhrajani, member of Legal Cell briefed the house that in an earlier case of Central
 - Bank, in 2017, the Supreme Court had held that different dates are acceptable but awarded Rs. 2 lacs to the PETITIONERS alone. It was decided that legal opinion be taken from a competent advocate in Delhi for and take further course.
- 6. Coverage of BOBEVRS2001persons under Contributory Medical Assistance Scheme of the Bank in Rajasthan High Court: The legal team informed that the present position be ascertained by Jaipur Zone team and apprise the legal team.
- 7. Short payment of Gratuity: It was placed to the house that after the meeting at Ahmedabad, Zones were requested to provide details of Gratuity cases filed by BOBROA members before the concerned authorities. Few of the Zones had given the details of nearly -250- cases. It was informed that Appellate Authorities had passed their orders rejecting the claims of the claimants in Kerala, Bareilly, Delhi. Pune cases are pending and the hearing is to be held on 23 March, '2023. He also requested concerned Zones that sample cases with following documents to be sent to Convener, Legal Cell.
 - i) Claim of Member to the Controlling Authority
 - ii) Bank's reply
 - iii) Decision of Controlling Authority
 - iv) Appeal filed before the Appellate Authority
 - v) Reply by other party to the Appellate Authority
 - vi) Decision of the Appellate Authority

It was informed by the Convener that the details of the claims will be collected from these Zones with sample documents and a decision will be taken as to which of these claims cover a good amount of areas and a suitable case can be filed. It was suggested by the house that case be filed in Kerala High Court where disposal of service matters are quite fast.

The National President expressed his views that there needs to be a greater follow up on the cases and if required, to avail services of advocates who will take up the matter in earnest. Shri Subhash Ahuja stressed the need to communicate to members the case number and the present position on quarterly basis for their knowledge. He suggested that the legal cell meet periodically and minutes duly signed by all members be circulated. It was also suggested that the legal cell should respond to issues raised by members at the earliest. By doing so the members would feel that they are taken into confidence and would give a feeling that things are progressing thus exhibiting transparency in the matters of Legal issues.

Shri Bansal, National President advised that Mr. Subhash Ahuja should identify a suitable advocate for Supreme Court matters and the legal cell will meet the advocate to chalk out further course of action. Mr. Thirumalai, Zonal Secretary, Chennai Zone will also accompany the legal cell as he is conversant with the issues in Madras High Court and decisions of other Courts.

At end, the Convener, Shri Malolan suggested to prepare a proforma for collecting of information w.r.t short payment of gratuity and also sought guidance / suggestions from the house for improving the activities of the Legal Cell.

The National President informed to the Legal Cell to convene meetings virtually and the proceedings thereof to be circulated.

Shri Harshad Desai, Jt. General Secretary, suggested to the members present, to send the contents timely on the activities carried out by Zones for printing them in the e-Bulletin "Sampark" on the dedicated e-mail id bobroa90.e-bulletin@gmail.com

Shri Jatil Patel, Executive President was invited for the concluding remarks. Appreciating the success of the inaugural session, he mentioned that the presence of all the invitees was the icing on the cake. It was informed that the proceedings of the Core Committee meeting was transacted based on the agenda given by the National President, Shri Bansal. He also informed that -02- of the suggestions which were brought forward were agreed by the house. Further, he stated that contributing Rs. 1,000/every year would go a long way in helping the Association to function even better than before. It was also assured that in March '2024, the target of the membership No. crossing 15000+ would be achieved. Executive President also shared that at present the Balance Sheet of BOBROA which is exhibiting a corpus of Rs. 4.74 Crs. should touch Rs. 5/- Crs. This would be possible by the concerted efforts put in and co-operation extended by one and all. Suggestions were freely invited from the members and to be communicated to Central Office. It was announced that the contribution of Rs. 1,000/- can be given today and the Executive President to set the trend, initiated the contribution. This gesture was replicated by National President, General Secretary and in turn by the entire house. Lastly, the efforts put in by Shri SNS Yadav and his team was duly complemented.

While proposing Vote of Thanks, Shri Ketan Dave, Asst. General Secretary, Baroda Zone extended warm greetings to the esteemed dignitaries, Office Bearers of various Zones, Governing Council Members, Volunteers and all others who had joined for the -02- day Core Committee meeting at the holy city of Varanasi. Shri Ketan Dave began by stating that he felt incredibly honored and privileged to have been allowed to extend the vote of thanks. He further, mentioned that to host such an event, that too in a grand manner requires lot of meticulous planning ably backed up by effective execution by not only the host Zone but also by the Central Team, Legal Cell, Governing Council Members, Team Lucknow Zone, their volunteers and all other supporting agencies. Shri Dave also informed that all present were immensely benefitted and enriched themselves by the deliberations undertaken in the two days marathon Core Committee meeting for which he complimented and attributed this success to BOBROA Team, Lucknow Zone in general and Varanasi Region in particular.

Thanks were also extended to all the in-Service Executives and invitees present whose presence not only graced the occasion but also gave the impetus to the Core Committee meeting.

Thereafter, BOBROA Team, Lucknow Zone were once again complimented for the task well accomplished with special compliments to Zonal President Shri Jafri and Zonal Secretary Shri SNS Yadav under whose able leadership and guidance the event was a grand success. This was followed by the house extending a standing ovation. The house also thanked for this wonderful gesture.

This was followed by extending special thanks to the Central Team under the able leadership of Shri Bansal Sir for extending their untiring support and guidance extended from time to time in making the event a remarkable success.

The house was also extended thanks for having travelled the length and breadth of the country and to have meaningfully and effective participation in the deliberations undertaken during the -02- days of the Core Committee meeting.

Lastly, thanks was also extended to the City Inn Hotel management, sound system agency, photographer and to all those who had contributed directly or indirectly towards the success of the Core Committee meeting.

As the event was hosted at the Holy City of Varanasi, Shri Ketan Dave chanted Har Har Mahadev with the entire house joining turning the entire atmosphere spiritual.

As no other matter was to be discussed the meeting concluded with sincere thanks to the Chair.

This was followed by the patriotic rendition of the National Anthem by one and all.

We invariably kept live this felicitation preferably on the due dates and at the respective home where able possible and also in the family get together/members meetings.

DONATION.....Our Zone remitted a sum of **Rs.51,603/-** to our esteemed Association in 2022.

SHORT GRATUITY PAYMENT CASES FILED IN ALC, BAREILLY

In 2019 we filed 85 cases in ALC Bareilly. 39 cases were dismissed by ALC, Bareilly and in 46 cases ALC awarded adding DA portion in the calculation. But ALC did not consider the followings:

- 1. Members who joined before 01.07.1979 and retired before 01.11.2012 were paid ARB and gratuity for 15 months for the service of 30 years. No gratuity was paid for service rendered over 30 years.
- 2. Members who joined before 01.07.1979 and retired after 01.11.2012 were paid ARB and gratuity for 15 months for the service. No gratuity was paid for service rendered over 30 years. Further while paying Gratuity special allowance was not considered in calculation as per the Bipartite Settlement effective from 01.11.2012.
- 3. Members of EBCBL and BSBL were denied of ARB who joined before 01.07.1979, however full gratuity @15 days per year for the entire service was paid.
- 4. Payment of gratuity @ one and half month over and above the service of 30 years was not considered.
- 5. Payment of 26 days was not considered.

We filed an Appeal in 28 cases in the cases dismissed by ALC (11 members did not file an Appeal) and also filed an Appeal in 46 cases where ALC has awarded payment of gratuity adding DA for payment of gratuity and claimed for the difference amount.

Bank also filed an Appeal in cases in Dy. CLC Dehradun where ALC has awarded payment of gratuity in approximately 46 cases which was allowed on deposit of amount as per rule.

Dy. CLC modified the order of ALC Bareilly to the extent to pay gratuity without inclusion of DA. Hence 72 cases were dismissed and only in 2 cases Bank has paid the Gratuity.

The information asked by BOBROA has been submitted by us in XL sheet giving all relevant details for taking suitable action in the interest of members.

We further provided the relevant information to Shri C Malolan on 25.02.2023. However soft/hard copies of sample cases will be made available by 10th March, 2023.

MEETINGS

In the year 2022 after the Corona pandemic was over the physical meeting took places in at the main centers /Regional Headquarters.

Meetings with members and family get- to gathers started momentum in 2022 and we had regular meetings at Agra, Aligarh, Jhansi, Bareilly, Dehradun, Meerut, Moradabad, Haldwani, Kashipur and Shahjahanpur


He also replied to the queries and questions of members and explained at length the efforts made at central office level. Meeting concluded with vote of thanks offered by Shri. Pathan.

In all 24 Appeals have been filed with The Dy. Chief Labour Commissioner (Central) Mumbai, wherein we have filed our Written Note of Arguments and Bank has also filed their Written Arguments, now all the cases are kept for oral arguments on 13/04/2023. The Hon'ble, Dy LC, Mumbai during hearing of 20th March 2023 observed that, Junior Advocate on behalf of the Bank attended the matter and was not in a position to make oral arguments and asked for adjournment, Hon'ble Dy. LC made observation that, if Bank Advocate does not appear for oral arguments on next date given, he may impose cost. The appeal cases are being attended by Shri P.D. Jahagirdar, a Member of legal group along with his team.

REDRESSAL OF GRIEVANCES:

The issues such as delay in release of family pension, PPO corrections, wrong debits, Stagnation increment, Medical checkup facility not in operation in Goa, notice of Lokadalat for recovery to member, Insurance claim settlement issues etc. are attended by our committee members, office bearers and resolved which are taken up at appropriate level AND also with intervention of CM HRM, RMs, ZH. etc., at local level. The Health checkup facility is made operational at Ponda Goa after our follow up. We have requested Bank Management to introduce facility at two major centers Mapuca and Margao Goa.




